### D. GENERAL INFORMATION & PROCEDURES

#### 1) IMPORT RESTRICTIONS

We do not recommend that you ship food stuffs, beverage or similar items to the exhibition as part of your consignment and these items can be purchased in Vietnam. Temporary importation of some specific products such as food stuffs, beverage, medicines, cosmetics, telecommunication, motorbike, automobile and similar items is subject to special import license granted by relevant Ministries. Obviously, drug, military ware / equipment and pornographic materials and strictly prohibited.

# 2) CUSTOMS DUTIES / TAXES / VAT

All the cargoes are under temporary import basis and re-exported totally after the show will be taxed free. For any cargos / items are to giveaway / consumed / abandoned or no return during the show are subject to import duties, taxes & VAT stipulated by Customs. Vietnamese Customs have a tax rate book and minimum price or market price to calculate import duties / VAT. Please give us the instruction of giveaway / consumed / abandoned items when shipping cargoes in order for us to calculate the estimate import duties & VAT. JES shall pay on your behalf and bill you the import duties / VAT before the opening. The exhibitors shall guarantee to us that the full amount of duties / VAT should be paid to Customs for those items are not return. For giveaway / consumed / abandoned items, the exhibitor should deposit to us the import duties / VAT in advance based on the estimate duties calculation. After the Customs gives out the concrete amount of duties, the amount balance (if any) shall be refunded.

### 3) CATALOGUES AND CONSUMABLE ITEMS - CENSORING

CDR, catalogues, giveaway, souvenir and similar items are subject to import duties / VAT as assessed by the Vietnamese Customs. Please declare the exact quantity and items with company logo. Vietnamese Customs will count each and every item during inspection. The censorship fee will be billed at cost.

#### 4) HEAVY AND OVERSIZES EXHIBITS

This applies to any single exhibit in excess of 1000 kgs and 5 cbm, that requires the use of a forklift or mobile crane for installation. Exhibitors with heavy and oversized exhibits must be on-site early to direct the operation of unpacking and positioning. If a mobile crane or forklift is required for installation of equipment, exhibitors should send your requirement to us as early as possible so that we could arrange contracting such equipment in advance. A quote will be given after receiving your enquiry.

#### 5) PACKING

Please ensure your equipment is packed in a strong, waterproof packing case which lends itself to being re-packed after the exhibition. Please bear in mind that your exhibits will be in transit for long periods both to and from the exhibition and that cartons are not suitable to withstand the constant handling which takes place during transshipment. Shocking and bumping will sometimes be inevitable and cases may be placed in open air storage without cover, therefore exhibitors must take the necessary precautions against damage and rain. JES will not assume any responsibility for damage, especially when the return exhibits will be repacked with the same used packing materials i.e.) aluminum foil and plastic covers.

#### 6) UNPACKING OR REPACKING ON -SITE

We will assist in physical unpacking and installation of exhibits, however exhibitors must supervise and be responsible for those operations. Similarly, during exhibition closing, exhibitors must also supervise the dismantling and repacking of exhibits, especially for delicate or heavy equipment. When exhibits are repacked with used packing materials, the packing is regarded as no longer suitable to protect the contents against damage and or moisture compared with the original. Exhibitors should therefore bear the responsibility for any consequences arising therefrom.

### 7) RE-EXPORT

Disposal and forwarding instructions will be discussed with you during the course of exhibition. Re-export formalities will require at least 20 days. Therefore, please do not make any plan on receiving the exhibits soon after the exhibition. We hold no liability for when the exhibits would be back to the desired final destination after the exhibition closes. If you need the exhibits to be re-exported urgently or transfer to other exhibitions, please contact our on-site representative of your request as applicable.

### 8) CASE MARKING

In additional to the special case labels which are available from our offices and agents upon request, all packing cases, cartons etc. being sent to the exhibition must be stenciled with the following information:

# 9) SOLD CARGO PROCEDURE

The exhibition venue is a customs bonded area and no cargoes may be removed without the permission of Vietnamese Customs. For sold cargoes, the exhibitor are allowed to sign contract and sell cargoes during or after the show. It is, however, subject to Customs approval. The exhibitor will have 30 days from the date of the show end to find out the buyer or complete the transaction. After this deadline, the shipments have to be re-exported out of Vietnam unless there is an extension permit from authorized organization. Sold cargoes will not be released until all taxes and customs fees have been paid by your buyer. It is likely that your exhibits will need to be repacked and removed to the Customs bonded warehouse until all necessary domestic customs formalities have been finalized. Sold cargoes pending for import license will be delivered to the Customs bonded warehouse. All charges will be for the exhibitor account. A sales contract is required by the Vietnamese Customs in order to calculate duties / taxes if any.

# 10) INSURANCE

As our tariff has been compiled on a weight & volume basis and has no correlation with value of exhibits, naturally no insurance has been covered in our charges and all work is undertake at owner's risk. It is the exhibitor's own responsibility to cover all risk insurance for the round trip transit period. JES and their agents can offer you insurance upon receipt of written instructions.

# E. <u>IMPORTANT NOTES</u>

- 1. The exact move-in / move-out schedule is subject to the Organizer's final arrangement and subject to change with or without prior notice. The exact routing is subject to availability.
- 2. All return shipments will only be arranged when all customs clearance procedures are completed and all exhibits handed over to us. As the demand for transportation facilities in Vietnam is great, exhibitors must not make any plan on receiving exhibits soon after the exhibition, since it may take over 20 days for exhibits to be re-exported out of Vietnam.
- 3. The volume / weight ratio for air cargo is 6:1 (i.e. 1 cbm = 166.7 kgs). The chargeable weight is based on the volume weight or actual weight whichever yields the greater.
- 4. All cargo must be sent with "Freight Prepaid" for inward movement. A 10% surcharge will be imposed for any shipment sent with "Freight Collect".
- 5. Unpacked cargo there will be a 20% surcharge for handling unpacked cargo. JES Logistics or its appointed agents will not be liable for any loss or damage.
- 6. Dangerous goods there is a 100% surcharge will be levied and the carriers will only accept dangerous cargo subject to availability.
- 7. The ATA Carnet is acceptable in Vietnam for usage as documents for temporary importaion. Please note that ATA Carnet shipment must be re-exported after closure of the exhibition, it cannot be sold. ATA Carnet handling fee of temporary import will be given upon request.
- 8. Relative to inbound shipments, there may be a lapse of time between the delivery of shipment(s) to the booth and the arrival of the Exhibitor's representative at the booth. Similarly, relative to out-going shipment(s), it is possible that there will be a lapse of time between the completion of packing and the actual pick up of freight from the booth for loading onto a carrier. It is understood that during such times the shipment(s) will be left in the booth unattended. Therefore, it is agreed that the Company and its sub-contractors are not liable for the loss of disappearance of, or damage to Exhibitor's freight after the same has been delivered to Exhibitor's booth, nor are the Company and its sub-contractors liable for Exhibitor's freight before it is picked up from the Exhibitor's booth for loading after the show. Consequently, all bills of lading covering outgoing shipment(s) submitted to the Company or its sub-contractors by Exhibitor will be checked at the time of pick up from the booth and corrected where discrepancies exist.
- 9. For additional services not listed above, an individual quotation will be given upon request. 
